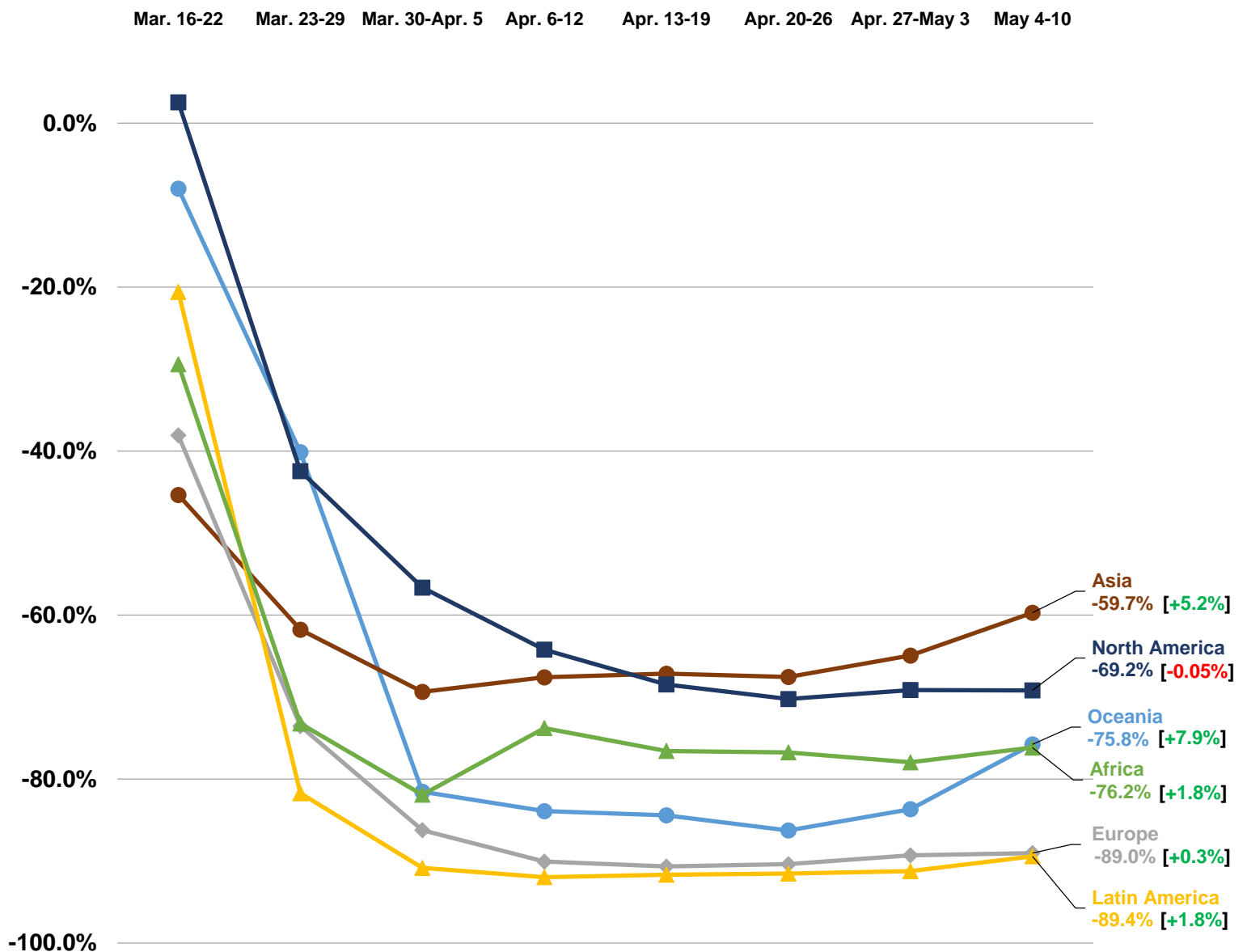

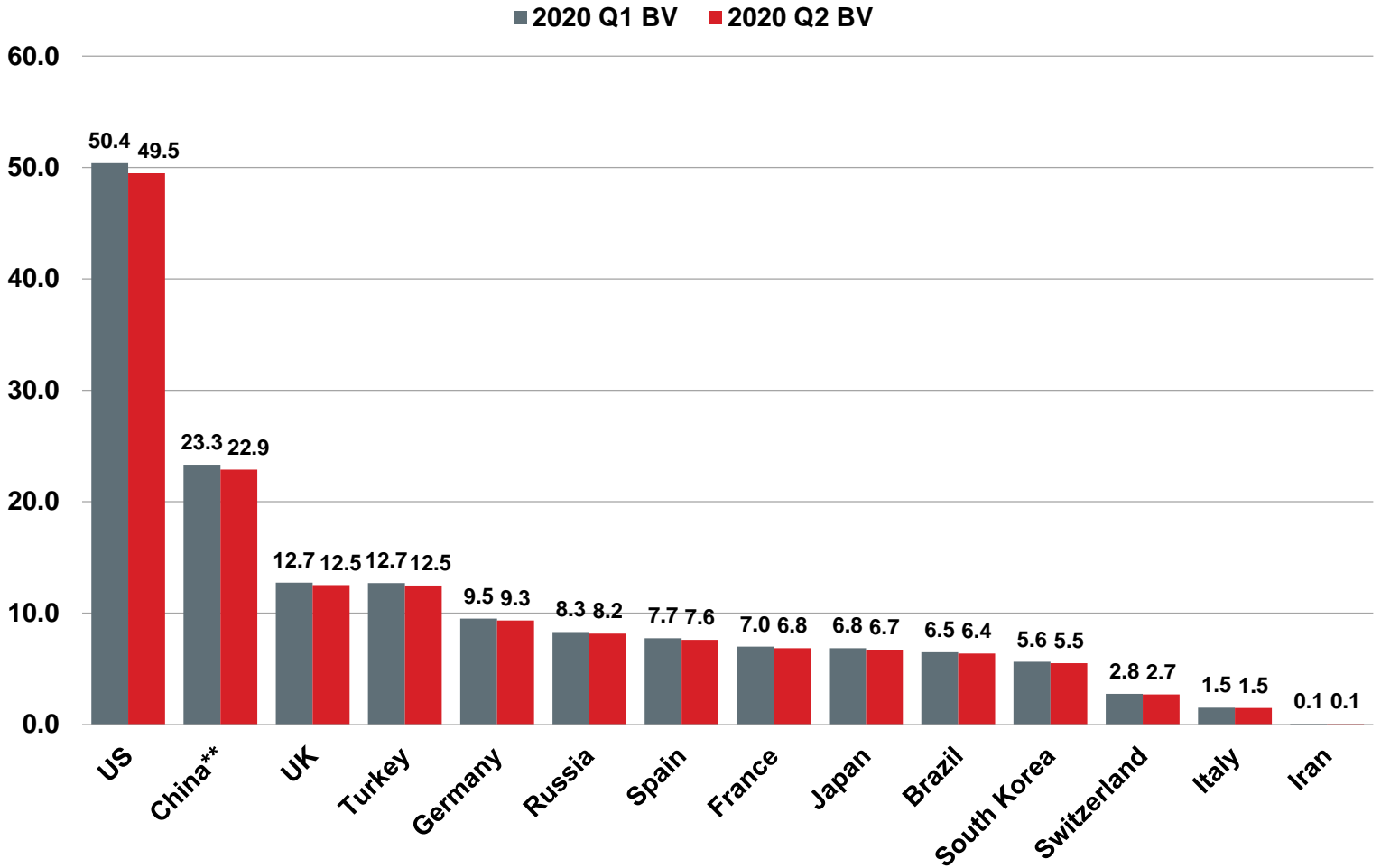

Decrease in Flights by Country* & [Most Recent Week-on-Week Change]

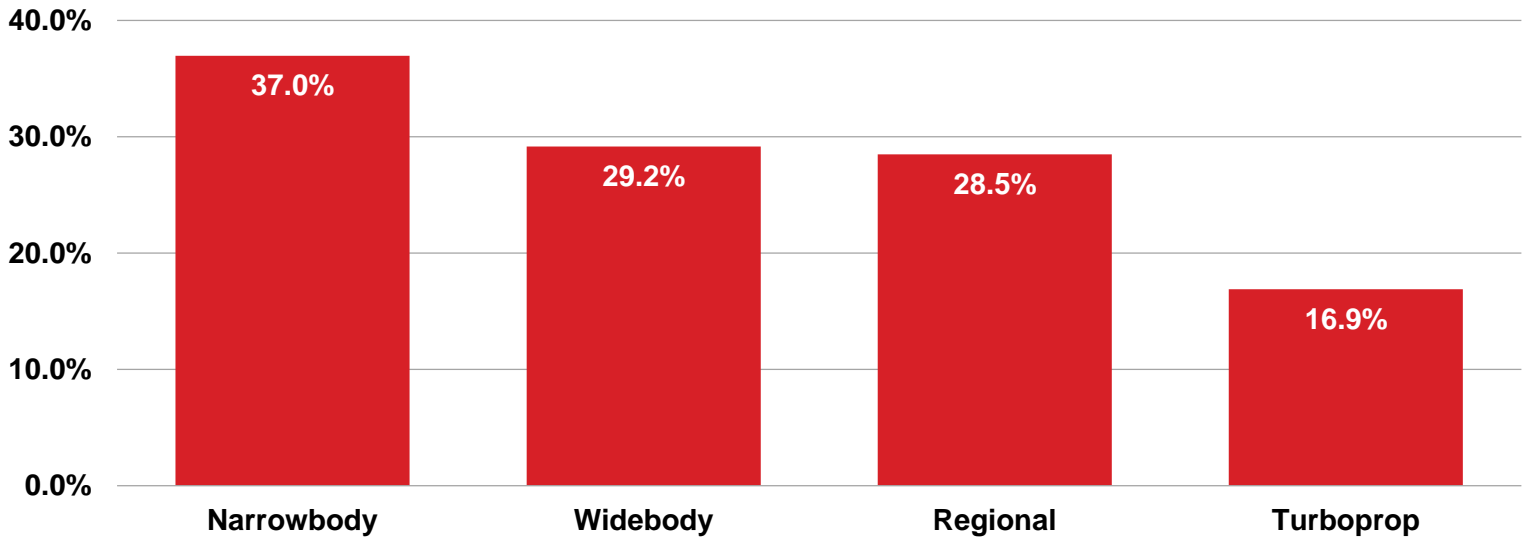


* Change in average daily flights scheduled versus control period of Jan. 4 to 16

Total Value of Parked Aircraft (\$ Billions)

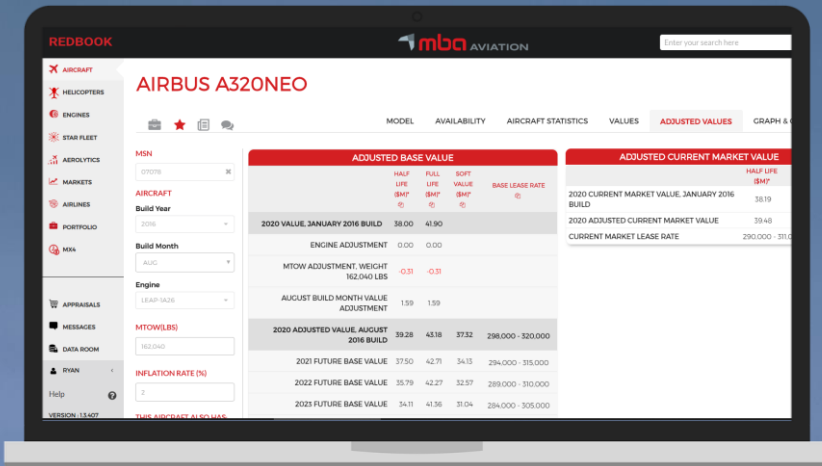


Aircraft by Body Type as a Percent of Total Fleet[^]
